The law library's fax and email is included, and if available, a direct phone number or email address for the librarian. Listings may include the names and contact information of the Board president and key staff members. For the most up to date information, contact the library directly for current information as changes may have occurred since the directory's compilation.

Electronic Service is provided in many libraries to law library resources and legal online databases. Also noted are the county law libraries with electronic/virtual/ digital access serving as its main law library or as a branch law library.

Branch and **Partnership** locations, phone numbers, and, when available, hours of operation are noted for those libraries that maintain branches and partnerships.
