	UCITA	A proposed state contract law designed to standardize the licensing of software and other forms of digital information. Will be introduced state-by-state. Restricts ownership of products or digital information and adds restrictions related to ownership and use of digital products. Vendors may monitor licensee usage online. Reduces or eliminates judicial process in cases of disputes between vendors and licensees.		“UCITA entered a new phase of its evolution this year as the American Bar Association began an exhaustive review of the statute in the fall and NCCUSL, National Commissioners who drafted UCITA, issued 19 new amendments in December, in an attempt to make the legislation more palatable to critics. 	Funding for FY 2002	The President's FY 2002 budget recommendation reduces the LSTA from \$207 million to \$168 million. Most cuts are in the National Leadership Grants program. Does not affect grants to states. (\$149 million)		"12/31/01 - The Labor, Health and Human Services, and Education Appropriations bill for fiscal year 2002 (H.R. 3061) was passed with broad bipartisan support by the House December 19 and the Senate December 21. The measure included \$197.6 million for library programs under the Institute of Museum and Library Services. Of that, \$168 million is for LSTA leadership grants and block grants to the states, and \$29 million is for set-asides for specific projects requested by legislators."		No position taken	Support
HR 3784	LSTA Reauthorization	Reauthorizes the Library Services and Technology Act for 2002/07. Broadens the scope of the act and requests an increase to \$500 million for block grants to the states.		Introduced by Rep. Hoekstra through the House Committee on Education and the Workforce. Co-sponsored by over 90 members of the house including a significant number of California representatives. Expected to go to a full floor vote the week of May 20. The House version has \$300 million authorization level.		Support	Support

S327	Improving Literacy through School Libraries Act of 2001	Amends Title II of the ESEA to provide up-to-date school library media resources and certified school library media specialists for elementary and secondary schools.	Sen. Jack Reed (D-R.I.)	“12/31/01 The new school library resources program, established under the recently reauthorized Elementary and Secondary Education Act, was funded at \$12.5 million. ALA recommends that the appropriation be increased to \$100 million, or more, which would increase the amount available and require that the funds be disbursed to the states as block grants.
